

Our Challenges:

Let's face it, road construction is hard work. Really hard work, in fact. Extreme temperatures, dangerous work environments, heavy physical demands, and high turnover in the workforce make this one of the most injury-prone job occupations out there.

In 2014 Manatt's Inc. was seeing increasing claims and medical costs resulting from musculoskeletal disorders (MSDs), among their workforce. This trend was increasing year over year and upon review, new hires or those with less than 18 months on the job were making up the majority of those claims.

Without prior use of a pre-employment physical function screening program, there was no method to confirm a new hire's physical abilities were in line with the prospective position. This lack of testing was a direct link to new hire injury claims. A new method had to be developed and employed across a geographically broad workforce to reverse this trend.

Seeing the benefits of this new program the client decided to incorporate nine separate physical therapy clinics as remote testing centers, which improved the overall hiring experience for candidates and significantly decreased costs in regards to time lost traveling to just one testing facility.


